**THE INTERNATIONAL STATE OF EMERGENCY: CONSTITUTIONAL EXCEPTIONS AND THE GLOBALIZATION OF SECURITY LAW AFTER 9/11.** After 9/11, the UN Security Council sprang into action, passing resolutions of a sort never seen before. Beginning with Resolution 1373 and continuing through a path-breaking series of other resolutions, the Security Council has created a body of global security law that requires states to change their own domestic law to comply. Regional bodies joined the campaign and also supported the Security Council framework with more resolutions, action plans and regional treaties. Faced with this united front of international law, states have complied at an astonishing rate. Every member state of the UN filed reports to indicate their compliance; the vast majority of these reports indicate that states in fact changed their domestic laws after 9/11. But many of those laws pose challenges for domestic

constitutions and constitutional values. In this book, I show how the Security Council framework has pushed states toward emergency powers, bringing international security law and domestic constitutional law into a head-on collision. To understand how states have responded, I develop a new theory of emergency powers that goes beyond the 9/11 cases.

**THE RISE AND FALL OF A LIBERAL CONSTITUTION: HUNGARY 1989-2011.** With Gábor Halmai and Miklós Bánkuti. From 1989, when the Roundtable Talks signaled the end of the communist regime, to 2011, when constitutional revolution swept Hungary again, Hungary had a liberal constitution that guaranteed rights, established checked powers and created a constitutional democracy. This book traces that constitution from beginning to end, and shows how this constitution came to be established as a set of political practices after 1989 as well as how it collapsed very quickly when some of its designers recognized its weak points. While the book is quite descriptive and focuses on a small country on the edges of Europe, it highlights processes of constitution-making and constitutional destruction that carry larger lessons about how fragile constitutional democratic regimes can be.

**COUNTER-CONSTITUTIONS: HUNGARY AND THE HOLY CROWN OF ST. STEPHEN.** After 1989, Hungary got a new, democratic constitution to go with the new, democratic state. But a tiny minority on the fringes of Hungarian politics argued from the beginning of the political transition that the true constitution of Hungary was contained in the doctrine of the Holy Crown of St. Stephen, a crown given to the first Christian king of Hungary by the pope in the year 1000. This tiny minority's view became the view of the mainstream right wing of Hungarian politics over the first 20 years of Hungarian democracy. As a result, the new constitution adopted by the Hungarian parliament in 2011 puts the Holy Crown and the "historic Hungarian constitution" at its core. In this book, I examine the debates over the Holy Crown of St. Stephen, tracking them back to their medieval roots and showing how the modern conception of the Crown was formed primarily in the interwar period of the 20<sup>th</sup> century. The interwar Crown came to stand for "Greater Hungary" before it was reduced in territory and population in the Treaty of Trianon that ended World War I. Contemporary invocations of the Crown, as a result, tend to replay a particular nationalist narrative about the years of Hungarian greatness. While the book deals primarily with Hungary, the Hungarian case is used to explore some enduring issues in constitutional theory more generally, like the way in which constitutions becomes fetishes and how national narratives are always more complicated and multivalent than they seem.
